Problem Statement: How might we create a smart document parser to streamline and enhance the process of information extraction and analysis for the financial analysis?

What Are We Looking For: A prototype seamless and use-friendly data parsing and extraction solution specific for the asset management industry that is able to perform most of the following functions including intelligent data extraction, NLP-based financial topic analysis, intelligent data contextualisation, centralise document repository, feedback loop and. smart searching capabilities.

IMAS – Automated Form Filing Workflow and Data Management for Asset Management

Problem Statement: How can we automate the form-filling process for asset management firms in a more accurate and efficient manner?

What Are We Looking For: A prototype solution that can (i) automatically extract data fields from the PDF form into a more structured format (e.g. MS Excel) and (ii) using the extracted data, to automatically populate data fields directly onto the OPERA system in subsequent/yearly updates.

Problem Statement: How can we have consistent and up-to-date measurements of ESG standards and requirements to better equip asset managers to - visibly and with impact - incorporate ESG considerations into investment programss and portfolios?

What Are We Looking For: A working prototype solution that can support asset managers to effectively support asset managers to effectively manage sustainable investment considerations, which should include one or more of the following features: Automated data gathering, easy search and retrieval library, digital reporting, digital collaboration and sentiment analysis.
