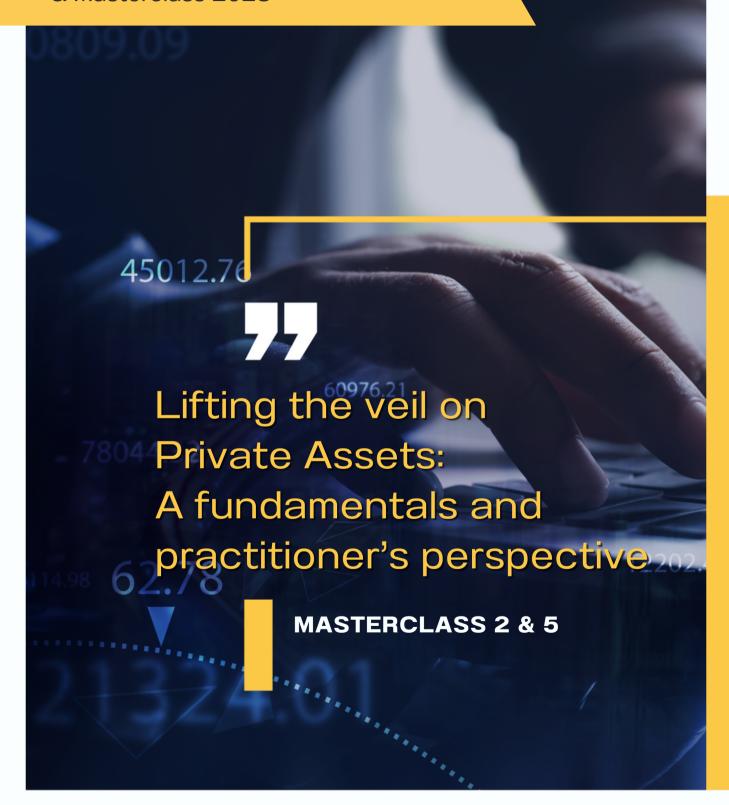

<u>Master Class - Lifting the Veil on Private Assets: A Fundamentals and Practitioner's Perspective</u>

Synopsis:

Institutional investors continue to increase their allocation to private market assets and seek out new investment routes and opportunities. Fuelled by a desire to diversify away from public market investments, lured by illiquidity premium potential, alongside safe harbour protection from rising interest rates and increasing inflation, appetite for private asset investment has never been greater. Additionally, the increased influence and possibilities for customisation of ESG considerations present a strong pull to investors keen to build tangible paths towards their ESG goals.

This Masterclass is designed for investors (LPs), managers (GPs), and intermediaries keen to build a robust understanding of the sector and explore its components. Participants will hear direct experiences from a leading LP (Fullerton Fund Management) during two interactive case study workshops and GPs in Private Equity, Private Credit and Venture Growth (KKR, Blackstone, and Asia Partners), alongside presentations from experienced trainers (from the CAIA Association and CapitalLand), and a facilitator closely involved in the sector (also from the CAIA Association).
